**Check in: MUST Check in At Fair Office Prior to Parking Unit.**

**Before you park your unit in a camping stall you must make arrangements. You must call 320-589-1062 or 320-760-6168 or you will be moving it.**

**Responsible party:** The name of the person the campsite is rented to is responsible for the entire site. Responsible party MUST BE 18 YEARS OF AGE.

**Campsite:** One camper/RV or 2 tents per site. There are a limited amount of sites available, first to reserve is first served. Sites with water and electric service are available, with limited availability. Restrooms and Showers are available within walking distance. Note additional lot starting in 2017

**Dogs:** Must be on a 6 ft. or less leash and **MUST stay in camping area. Dogs are not allowed on other areas of the fairgrounds at any time.** \$150 Fine and you will be asked to leave if you do not pickup your dogs do-do.

**Parking:** **Only when available in camping stall,** parking is available in the main parking lot. Absolutely NO 4-wheelers or golf carts allowed. **NO unit may park on Driveways and MUST be within your camping stall.**

**Fire:** Campfires are NOT allowed unless LP and approved. Propane and charcoal grills used for cooking.

**Garbage:** You are responsible for cleaning up your site before you leave. Dumpster is available.

**Law enforcement:** Local law enforcement will patrol the campground to insure safety. In case of emergency, please call 911.

**WAIVER:** I have read and understand the rules above. I agree to take full responsibility for my site and the actions of persons using it. I agree to release the Stevens County Fair Board (Stevens Co. Ag Society) from liability for accidents or injuries to persons or property.
